Subject: Release of excess land for educational purpose - reg.

Sir,

1. This has reference to your letter dated 30.06.2015, regarding release of excess land for other educational purpose.

2. In this regard, it may be informed that the matter regarding use of excess land for other educational purposes by a Trust / Society was discussed by the Executive Committee of the Council in its 84th meeting held on 29.08.2013 (Item No. 84.03.01). The Committee had taken following decision in the matter:-

"The Executive Committee deliberated and approved starting other educational courses / Institutions (Technical / Non-Technical) in the surplus land arising out of prevailing / reduced norms of land requirement. EC also approved that such surplus land can be used as per the land use certificate given to the Society / Trust by the concerned authority subject to such courses / institutions having their own facilities to conduct such programs without sharing the essential facilities with the already approved technical Institutions."

3. Keeping in view the above decision of the EC, the Council has no objection for utilizing the surplus land for starting other educational courses / Institutions (Technical / Non-Technical) in the surplus land arising out of prevailing / reduced norms of land requirement. The surplus land can be used as per the land use certificate given to the Society / Trust by the concerned authority subject to such courses / institutions having their own facilities to conduct such programs without sharing the essential facilities with the already approved technical Institutions.


**Subject No. 4 : Allotment and allocation of land from survey No. 7480, 7323

Resolution : The AICTE vide their letter No. MS-06/MCP-CS/95 Dt. 21/09/2015 has
given sanction to release the extra land allocated previously to College of
Engineering & IT and IMR as per old norms of requirement of land for
different institution like Engineering College, IMR College. According to the
revised norms of land requirement by AICTE 2015-16, the land from CTS
No. 7480 (Total area 7.27 acres), is allocated and earmarked for the above
institutes as below -

- 1) IMR - 1.20 acres,
- 2) College of Engg. & I.T. - 2.52 acres,
- 3) D-Pharmacy - 0.80 acres,


Total - 4.52 acres

From the release of above excess land of CTS 7480, the piece of 0.8 acres
of land is proposed to be allocated and earmarked for the development of D-
Pharmacy College as per AICTE norms. Even after utilising the land for D-
Pharmacy College, about 2.75 acres of land remains available for further
development of other project by the society.
