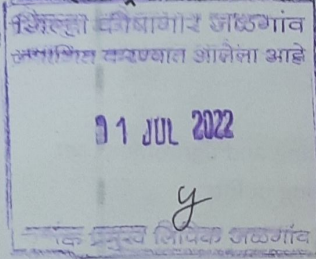

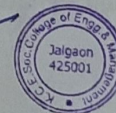

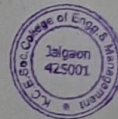
**SCOPE**-Both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their skills and knowledge.

**VALIDITY**- The validity of the agreement is three years from the date of agreement.

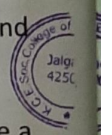
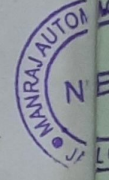
