Now therefore, in consideration of the mutual understanding and agreement set forth in this MOU, both the parties hereto agree on following points.


\*There will not be any monetary transaction in this regard.

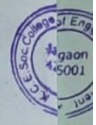
